demolish and relocate a section of Nebo Church Road and then use the soil to fill a future apron expansion area were approved by council this fall. The third portion of the overall picture is to pave the expansion area to increase parking for aircraft.

"Hopefully we can put this new news in with the current plan we have to create a more cohesive approach for airport improvement," Brock said.

The apron expansion should hold around 15 large-span aircraft or 64 smaller planes, Brock said, noting anything with a wingspan of more than 90 feet is considered large. Paved parking also decreases reliance on staff and machinery at the airport, she said, making it more self-sufficient for customers.

"If we put them in the grass and it rains, we have to use additional resources to get them back out of the grass," Brock said. "This is just one more step in having a complete customer service airport so there's less reliance on machinery and more reliance on the actual aircraft."

To clarify some of the confusion surrounding the safety violations requiring the demolition and relocation of Nebo Church Road, the county hosted a drop-in meeting at the airport on Nov. 7.

"We had about 62 people

come and attend, (and)
most everyone there saw
physically standing on

the ground — saw the runway impediment, and I feel most certain they have a better understanding of what was happening there as far as the safety and the (runway protection

zone)," Brock reported to council at its November meeting last week, "I feel like we had

a great turnout and good

SENECA — In the midst of two airport improvement projects that caused a few headaches for locals, Oconee County got word Friday that the airport has been selected for an additional \$1.2 million in federal grant money.

The new Federal Aviation Administration grant will be used for the paving of addition-
